## Executive summary

#### **Purpose**

The purpose of this paper is to provide an update to the Joint Committee of CCGs on a process to refresh the work plan. The Joint Committee is asked to approve the process set out below.

#### **Background**

The Joint Committee of CCGs has delegated authority from individual CCGs to take decisions on their behalf. A Memorandum of Understanding formalises the operation off the Joint Committee and the scope of the service areas this delegated is defined through a work plan that is agreed by individual CCGs.

The existing work plan was developed at the end of 2016 and signed off by CCGs in early 2017. The work plan was high level given the relative immaturity of the work programmes. It included:

- Cancer
- Hyper Acute Stroke Services
- Mental Health
- Urgent and Emergency Care
- Standardisation of Commissioning Policies

Schedule 4 of the Memorandum of Understanding states that the work plan will be reviewed within the first six months of the operation of the Joint Committee.

This process provides an opportunity refreshing the plan to provide greater details on the specific decisions that the Joint Committee might take.

#### **Process**

The proposed process for updating the plan is as follows:

- The Joint Committee governance team will work with the existing programmes listed above to update and sharpen the specific asks of the Joint Committee;
- A draft of the updated work plan will be discussed at the development session in October 2017;
- Subject to amendment and agreement the work plan will be shared with the individual CCGs for sign off;
- The work plan will be brought back to the Joint Committee in January 2018 for final sign off.
